WGHS NAMING COMMITTEE RECOMMENDATION

Dr. Moore opened the discussion of the WGHS Naming Committee recommendation to name two areas on the second floor of the new WGHS addition. WGHS Principal Dr. Jon Clark shared the following recommendations:

- Name the north hallway of the second floor social studies department the "Douglass School Social Studies Hallway" in order to continue its efforts to recognize the contributions Douglass School made to the Webster Groves School District community.
- Name the social studies department conference room the "Jim Shapleigh Conference Room." Mr. Shapleigh spent over 40 years as a teacher, principal, and counselor at WGHS, and since his retirement he has spent the last 21 years volunteering his time to provide individual tutoring for students within the high school.

Board members then discussed the proposal including displays in the respective areas explaining the choice of names, the possibility of providing the information on the district web site, the possibility of including the information in the Future Leaders program, and the importance of avoiding too narrow of a description in the names of the spaces.

Following the discussion, Mr. Kearney moved, seconded by Mr. Loher, that the Board of Education approve the north social studies hallway in the new addition "Douglass School Hallway." The motion carried 4-0 with one abstention.

Mrs. Dugan moved, seconded by Mr. Loher, that the Board of Education approve the social studies conference room on the second floor of the new addition "Jim Shapleigh Conference Room." The motion carried 4-0 with one abstention.
