

Request for Qualifications / Architectural and Engineering Services Design Package #2 – District Safety, Security, and Accessibility Improvements Webster Groves School District

Date of Issue: February 11, 2019

The Webster Groves School District is seeking responses to this Request for Qualifications (RFQ) from experienced firms who specialize in the design and development of educational facilities. The statement should conform to the following format. Please provide all information requested.

Note, if your firm is submitting a response to both Design Package # 1 and Design Package #2, you will need to submit two separate and individual responses. However, **Part Two- Firm Description** may be deleted in your response in Design Package #2, as it will be adequately covered in Design Package #1.

Part One - Project Description

The scope of work associated with this RFQ consists of facility improvements at multiple locations. The following project description provides a general overview of the work intended at each location.

Safety, Security, and Accessibility Improvements - Facility improvements that have been defined for some or all of our buildings will include upgrades to selected existing systems and assemblies along with the implementation of additional measures to further the safety, security and accessibility needs for all District buildings

Safety and Security: *SECURE/SINGLE POINT CONTROLLED ENTRY AT ALL BUILDINGS* (except Hixson Middle School)

1. At each campus create a secure vestibule with 2 sets of electronic entry doors, service window and video monitoring.
2. Interior office and classroom doors to be secure (glass mitigation where needed) along with accessible/operable hardware.
3. Each exterior door to be secured (glass mitigation where needed) have alarm capability and video monitored.
4. Address ground level window visibility – Install blinds, film, tinting or other means to deter/prevent interior visibility/entry from ground level windows.

Accessibility: *EVERY, BRISTOL AND EDGAR ROAD ELEMENTARY*

1. Installation of elevator(s) and/or stair lift(s) as needed in order to make these multiple floor buildings more accessible.

- a. Please identify and describe at least three educational projects that your firm has completed within the past five years that are similar in scope and size to the projects identified in this RFQ.
- b. Describe your firm's history of maintaining the client's master project schedule and budget.
- c. How will you insure quality control for the work of your firm, as well as for the work of any professional / engineering consultants?
- d. Please identify if your firm has ever been terminated for default within the last five (5) years. Termination for default is defined as notice to stop performance due to firm's nonperformance or poor performance. Submit full details of all terminations for default experienced.
- e. Please provide a minimum of five (5) client references for projects of like size and scope.

Part Four - Specialized Firm Experience and Interest

In relation to the Project Description outlined in Part One, please provide any additional information to the following:

- a. Please provide your firm's specialized experience and technical competence associated with the staff that will be assigned to this project.
- b. Based on your experience and qualifications which project(s) do you believe that your firm has the capacity and capability to perform?
- c. Regarding the questions above, please specify any unique qualifications your firm possesses related to the specific projects to be completed by the Webster Groves School District.

This information will be used to assist in the screening process.
