RE: ST. LOUIS COUNTY PROPERTY TAX COLLECTIONS

Please find enclosed a spreadsheet outlining the school district's year to date property tax collections. We are currently collecting close to the same as last year for current property taxes. We are approximately \$200,000 behind in delinquent property tax collections. Delinquent tax collections are hard to estimate. In any given year a property owner may choose to pay their current taxes or not. If they fail to pay current taxes by December 31, their tax payments become delinquent payments. There are no solid projections to determine delinquent tax revenue besides historical trend-line projections.

We will continue to monitor property tax collections throughout the rest of this fiscal year. Further updates will be provided in budget reports this spring. Please do not hesitate to contact me if you have any questions.
