Thanks again for taking the time to respond. I do appreciate it.

I'm going to keep the BOE on this thread becuase I think they need to be aware of my concerns and your answers below.

Yes, I realize these methods are and have been put in place for several years now in some classes. This is partially what I have complained about. The fact that the teacher just says - "here is your assignment - go find the answer on the internet". That's not actually teaching. In my eyes not acceptable.

S & W was voted down. The School of Innovation was part of that. Why do you proceed with something that the voters said "NO" to?

I realize there is a real push from the national level and the 21st Century group to implement this "Student Directed" / "Learner Directed" style vs. Teacher Directed. This Constructionism view of teaching is really not new. It's been around, from what I have read, since the early 1900's. The learner directed style, which theorists believe instills critical thinking skills, I believe should be used at the College and University level. For early education and K-12 the basics and foundation building should be the emphasis on which to draw upon in upper levels of education. I'm finding just as many "Con" articles disputing this form of teaching as there are "Pro"

My concerns are that WGSD seems to have adopted this new 'teaching style' without any real data to support its effectiveness. It is being brought into Steger 6th grade science classes next year. 6th

grade science is not a MAP tested year so how will you define success/failure? There seems to be no accountablity in measuring its effectiveness. In addition, it has not been discussed or inclusive of the parents at the level it should be. Parents are not given the option to "opt" out. Most parents don't pay attention so it's easy for you to slip this into the schools. We, and many other, moved here because of the strong traditional schools. I don't want to have to micro manage the school district. I want to trust the schools. Transparency of these changes have not been forthright. Why not set it up that parents can "opt" out. Let some other school district be the guinea pig and experiment with learner centered style.

I can tell you for Math (Algebra/Geometry/Calculus/Trigonometry), Science (Physics/Chemistry/Biology) I want a book and a Teacher Directed class. My son, who was in 7th grade algebra, told me stories of how he didn't know what was going on because kids were supposed to go to the board and solve and teach other kids. He passed that class because I worked with him A LOT. For science this year they did a student led "Boat Riggata" - build a boat out of card board and duct tape and see whose goes the farthest in the pool, i.e doesn't sink. This is an example of "project based" or student centered, however it was never pulled together for the students at the end. What I mean is, Team A's boat made it the farthest. Did the teacher talk about why that boat won? Construction, water displacement, boyancy, surface area, balance, etc... No, they did not. What did the kids really learn from it? When I asked the team why they won the "Best Engineered" boat, they looked at me and said "I don't know".

I have more research to do on this subject. I know you reached out to Adrianne as well and she is setting something up. I'll probably join in.

I'd also like to know what BOE members have kids currently in the district younger than 8th grade. Since this appears to be affecting them the most.

It will be very hard to sell me on this without hard core data correlated to state standards. The data that someone pointed me to on the community connect actually shows that the "innovative" schools in Colorado are performing BELOW state standards. See the appendix.



Dear Laurie.

I've responded to your inquiries below (taken from earlier email), and would really like to meet with you to discuss things more in depth if you're willing. I'd be happy to sit with for as long as you'd like. Let me know! Have a great day...John

What is/was the impetus for the School for Today? Are ACT scores low? Are MAP scores low? A few years back we had a committee that initially formed to explore whether the district should provide free, full-day kindergarten. During that process, we discussed how learning looked in our preschool environment compared to kindergarten and then other levels. Among other recommendations, the group recommended the district create a lab school or "school of innovation" in order to explore innovative practices. Following two other studies, the concepts for the "school of innovation" were presented to the board in the "School for Today" report. Because the actual "school of innovation" was part of the S&W proposal, our goal now is to gradually support the implementation of the concepts in varying degrees within our classrooms.

The "School for Today" wasn't initiated to improve MAP or ACT scores, but we do believe that if children are engaged in learning that has relevance and meaning to them, scores will go up.

I cannot find another public school in the USA that does the "teacher as facilitator" for K-12. Can you point me to other public schools in the USA that use this method for K-12?

Actually, these days you would be hard-pressed in most school districts to find a "teacher" that doesn't refer to himself/herself as a "facilitator" or see that as his/her primary role. The shift is really just in what teaching looks like – from dispenser of knowledge (sole method) to someone who creates more opportunities for students to learn through discovery, exploration, and problem-solving. Many "teachers" have done this for years. This doesn't mean that teachers don't still impart wisdom and directly instruct children as needed. Our goal is to help make learning relevant, rewarding, and challenging for all learners, and we believe this is best accomplished by giving the learners more autonomy or "voice" with their learning.

Can you point me to other public schools in the USA that use this method for K-12?

I would guess that in the majority of public school districts in the USA the teacher would either see himself/herself as more a facilitator of learning or is trying to move toward it. In terms of public schools, I don't know of any that are fully "learner-directed" or "democratic" such as some of the independent and private

schools you probably saw. That doesn't mean they don't exist. We're not trying to become one of those schools, but we are working to explore and find ways that learning in the classroom can be as learner-directed as possible.

Webster University did conduct research in a classroom at Hudson and I believe the results will soon be available. Was it fully "learner directed?" No, but the staff did work hard to try and have the students' interests and inquiries at the heart of the learning that took place in the classroom. We'll share the results when available.

What is the district's timeline for rolling this out? Please be specific of where and when.

There isn't a timeline per se for rolling out the concepts including any specific locations for doing so. Having said that, we are thoughtful in how we attend to the concepts in all that we do including the development and support of teachers. Many teachers across the district have been trying to implement these concepts for years, well before the "School for Today" report. At WGHS, a student can walk into the Chelsea Detrick Experiential Learning Center and express an interest in learning more about a topic or career. The teachers there will do everything they can to provide that student with an experience or even a course by working with him/her, other teachers, and possibly community members. Soft seating and maker-spaces are more observable across the district now than they were 10 years ago. More students are learning in the community and more community members are coming into the schools to help children learn. These concepts were not completely absent from classrooms prior to the "School for Today" report, but they are becoming more and more observable in the past few years.

Is the intention to use this for all classes in every school?

We do believe that every teacher in every classroom should move toward these concepts in a thoughtful, respectful, and responsive way. Having said that, it is more difficult at some levels and with some content areas for a variety of factors including the curricular outcomes and the amount of time students are in class.

Where is the hard data to support that this style of teaching is better?

There's data out there to support engagement in relevant learning, the effect of space on learning, and the value of learning in authentic contexts. Since the "School for Today" is a blend of four concepts, I don't know of any research encompassing all together. I will share with you and others the results of what happened at Hudson this year, and the research we conduct moving forward.

I would like to see how they fair on their state tests.

- 4. Where is the hard data to support that this style of teaching is better?

This last year at Clark, the art program switched to use something called TAB. I had no idea this was done until the end of the year. Each year on the last day of school my daughter always comes out with 4 or 5 really good art pieces. We hang them up around the house. She loves art. This year on the last day of school she came out with nothing. When I asked her where all her stuff was she teared up and said she didn't have anything. As a parent that is NOT something you want to hear or see. She explained to me that this year the kids got to choose what to work on and they only had a couple mini lessons. She didn't really get any instruction and couldn't decide what to do. If this is an example of "Child Directed" learning and "Teacher as Facilitator" then her experience and mine as a parent was not good.

If you could please supply the answers to my questions above, I would be happy to do some research.

These changes that you are talking about making from teacher directed to student directed are dramatic. Roughly 23% of the population of Webster Groves have kids in the district. That leaves 73% that do not. They are unaware of the changes you have planned for the district. Their home values are at stake here if this fails. It is unfair and irresponsible of you to not take the time to inform and get their input and feedback. There are 23,000 people who live in Webster. Only 60 people participated in limited fashion in this "Collaborative". 60/23,000 = .2% of the population. Yet this can affect all homeowners. Most older people who I talk to about this who don't have kids in the district are terrified. I, for one, do not want my kids to be guinea pigs. I did not move back to Webster Groves for a School District that uses student directed instruction. I expected tradition methods, i.e. teacher directed learning. The fact that you have been planning this for years is concerning to me. I guess I wasn't paying attention. But honestly I never suspected you were going to change an entire teaching philosophy. In addition, it appears that there is no third party or outside source way to measure the success/failure of this new teaching philosophy.

I already have issues with the lack of any organization of material in classrooms. My son is in 8th grade. My daughter is in 5th grade. Some use Edline, some use Google Classroom (which is just an unorganized feed), some use blogs, some use nothing. There appears to be ZERO consistency. This is not good. It takes my son an hour just to find the material in google classroom in order to study for a test. Seriously, stop being so cheap and sign a contract with Pearsons or somebody else for online text. When teachers say "go out to the internet and find the answer" do you really think that is acceptable? We all know how inconsistent data is on the internet.

I know this is long but here is the summary:

- 1. I am completely against using the Democratic student directed learning for any core classes. Those are Math, Science, ELA, and Social Studies. If you want to do a single Genius hour or Discovery class that's fine but leave the AP and core classes alone.
- 2. I would like some consistency between classes and teams with the way and where the material is presented. It is unacceptable to tell the kids to just go to the internet and look up an answer such as force = mass * acceleration.

Many parents are concerned about this new teaching philosophy. They are afraid to speak up. They don't have the time to fully understand the implications.

We elected you to represent us and I am letting you know as a parent I do not agree with this new teaching style. I will do what I can to try to educate people who don't have kids in the district of its existence and the trajectory the WGSD is heading. I suggest you spend some money and buy the

Dear Sarah,

I waited until the school year ended to ask these preschool related financial questions. This is a concern I have had since last spring. I thought my requests would go to Marty and told Lori I'd be happy to have Marty call me or I could e-mail her directly. After Lori sent me a file, you kindly sent another corrected one, so I corresponded with you. Natural follow up questions arose once I learned some staff were only partially paid from the preschool budget, yet didn't know the % paid by other budgets, nor by which ones. The Saturday reminder followed the BOE meeting we both attended.

I think it is wonderful staff is shared by more than one program. However, I believe the accounting for their time expended needs to be accurately represented. For years, one preschool director was paid ~\$95,000 for salary from the preschool budget, yet the second preschool director was paid ~\$117,000 from the general district funds. After the ~\$95,000 director departed, the second director's salary was not moved to the preschool. I find that odd. This year, if the preschool director took on more Adventure Club leadership, wouldn't the majority of her salary still originate in the preschool budget?

Unless all the WAFC expenditures are credited to that program, how can any of us know to what degree taxpayers (or Adventure Club parents) are sustaining the WAFC preschool? As long as the program is tax payer supported and uses resources that could be directed to the K-12 program and it is not self-sustaining (aside from building and grounds), my questions are relevant. A great many resources appear to be on hand for the WAFC preschool, despite its enrollment decline.

- I raised concern last spring after every building principal was required to reduce the aide budget by 10%. WAFC preschool was exempted.
- I have already raised the question of how to know the parent tuition fees are appropriate unless all expenditures are accounted for accurately. Last spring I learned the 2013-14 WACF preschool tuition collection was in the arrears by approximately \$35,336, yet the district asked taxpayers for \$0.03 for preschool scholarships while it supported ~\$211,000 in WAFC directorship.

• We know the WAFC preschool's enrollment has declined by 81 children (37%) in just 4 years, 2011-20115, per DESE data, following a major change in its focus. That tells me some parents love the new program, but others have clearly chosen to not send their preschoolers. Do we want to be financially sustaining a preschool model parents seem to not be selecting?

• We also know the preschoolers who are served by the Special School District (SSD) in WGSD are largely NOT being served within the WAFC preschool. I understand working parents often take their young children to childcare centers at their employers. Others prefer private preschools or to have SSD services in their homes. Wouldn't we hope our district preschool would be developing very early relationships with these young children and their parents, so that once those children begin kindergarten, their needs are well known and the parents feel a part of the WGSD community?

This past school year there were 83 preschoolers living in WGSD with IEPs; only 24 (29%) of them were served at WAFC. Why?

• While we have been told some elementary schools, particularly Avery, are bursting at the seams, the WAFC preschool utilizes only 8 of its 12 classrooms as classrooms. It has the lovely luxury of using the 4 other classroom spaces in other ways, 1 for an office and 3 for "ateliers".

- As I already mentioned, at least one teacher was reportedly paid extra pay to pull weeds and maintain a garden at WAFC. This seems to me a real luxury in expenditures, considering we have elementary children who reportedly told their parents this past year the district had no money for folders or books.
- The percent of administrative space of the total space at WAFC is a whopping 36%, according to the facilities committee reports.

My clarifications e-mail from Wednesday, June 15 may have been lost; I'm sure you have many, many other things upon which to focus. I've decided to copy in John and the BOE for transparency, so they can all see my questions and concerns. Maybe by a larger cooperative effort, these key budget issues can be examined.
The clarifications questions were to ask you to please answer more questions that rose from your reply to my original questions on June 9th, below, in quotes, blue, italics:

"Laura lannazzo is listed as the FACE coordinator, so I assume she paid by the state, not from the WAFC preschool budget."

What percentage of the salaries of Marty Baker, Elizabeth Paris, Katie Heisel, Christine Stukel and Lisa Lipps is paid from the WAFC preschool budget, please?"

You provided information that stated several of the WAFC preschool staff are only partially paid by the preschool budget, some as little as 20% and 33%. In fact, its director was 100% paid by Adventure Club this past year, you wrote.

I know in years prior to this past year, the WAFC preschool director, Marty Baker, was paid entirely from the general "Administrator salaries" line item #92 in the WGSD budget, not the preschool budget, line item #84. I expressed concern about this many times in writing last spring and summer and once in a public comment last spring at a BOE meeting. This past fall, it was announced her salary was finally moved to the WAFC preschool budget for 2015-16. It seems, that is not the case.

As you also may recall, I asked repeatedly last spring (2015) to see a WAFC budget and was told one didn't exist. Finally, after many requests, I was provided a listing of its major revenues and only the total expenditure sum, with no expenditure detail. However, what I was provided was just a 'snapshot in time", b/c that R/E figure decreased by ~90% in the 3 weeks following that last May/June.

I also I pointed out to Dr. Moore, as of spring/summer 2015, the WAFC tuition wasn't represented in the WGSD budget. In fact, there was no "Preschool Revenues" line item at all in the budget, although there was a "Preschool Expenditures" line item #84. There was no way (there still is not) for anyone examining the budget to line up the total revenues with total expenditures.

A portion of the WAFC preschool revenuers, "preschool tuition", had been wrapped into WGSD budget line item #11 "Other Local", which also contained gate receipts, bus pass money and more. Dr. Moore did break out the "preschool tuition" into its own sub line item, #11b for this year, 2015-16, however, other preschool revenues are not represented appropriately, in my view.

I realize, the Adventure Club coordinator, who was paid entirely from the Adventure Club budget, retired June, 2015. You said this past year Adventure Club was managed without a coordinator. I would assume, then, Ms. Baker took on more of a leadership role than perhaps she had in the past. However, since her primary role is director of the WAFC preschool, as listed on its website and as she identifies herself, it does seem odd 100% of her salary last year was paid from the Adventure Club expenditures, line item #81.

The pre/after school, tuition based Adventure Club program is entirely a separate entity from the WAFC preschool. Parents, most of them working parents, pay tuition to the Adventure Club program, I would assume, expecting that tuition covers the operating and staffing of that program.

I have not been able to see a WAFC detailed budget to determine if the preschool is self supporting or if the district supplements its revenues in order to keep it operating. This is a relevant question, given the fact other district preschools can demonstrate they are, indeed, self supporting and, in fact, many are surging in enrollment, have wait lists and are making profits. I requested to see the detailed WAFC budgets for the past 3 years again a few weeks ago and was told I'd need to pay \$48.22 just to look into it (no promises of obtaining them). I declined for now, since I had just pd \$33 for 10 years of supt enrollment reports and only then was told you had 4 years of them. When I persisted, I was told you found one additional year. I do appreciate receiving those reports, to learn more in advance of the upcoming demographics study findings.

WAFC parents I have asked have never been shown WAFC budgets. How do they know their tuition payment sums are appropriately aligned with the operational needs of the program? Do WAFC preschool parents know its director hasn't been paid from the WAFC preschool budget in years, if ever?
If the district budget indicates the WAFC preschool is essentially "self supporting", but one of its largest expenditures, the ~\$117,000 salary (plus benefits) doesn't even come from its budget, this is not a correct indication.
Since the WAFC preschool has been shifting its administrative cost onto the general WGSD budget and now to Adventure Club, what HAS it been expending its revenue on, then? I hear WAFC teachers have been paid overtime to weed the garden and other expenses I consider unusual.
That is why I would love to see a detailed budget.
My follow up questions are, therefore, logical, to ask, please, what budget pays for the remainder of the WAFC preschool staff who share duties with FACE, Adventure Club and, perhaps, the WGSD. I have attached the staffing list you originally sent. Thank you for it. On it, I have added, in blue, the information you provided about the budget origin of shared staff. In blue, listed below that, I pasted verbatim, the list of staff posted on the WAFC preschool web page, as of last week.
I will repeat by clarification questions from June 15. They are pasted, below, in blue, italics and quotes:

The federal Department of Education and the United States Justice Department sent letters to public school districts with guidance on the civil rights and treatment of transgender students. The Webster Groves School District is an equal opportunity employer.

Mr. Loher.

Thank you for your e-mail of May 25, 2016. I appreciate your candor.

You response is inadequate. Let me explain in sufficient detail for you to understand.

I understand your reticence to apologize in public. I also understand why your e-mail of May 25, insufficiently addresses the problems you have created for the school board

and the school district. Specifically, I understand that you believe your obligations are satisfied because you have:

- (a) sent Mrs. Barry an e-mail on 4/26
- (b) offering to meet as [you] said on 4/25 that [you] would do.
- (c) I understand that Ms. Barry may also have responded on 4/29 and that
- (d) you both may have corresponded via e-mail.
- (e) I further understand Ms. Barry may not have given [you] a time/date when she would be available to meet.

All of those statements (a) - (e) may be true. Let's accept as you suggest that they are. Just because those statements are true and occurred does not relieve you or absolve you of your obligation to apologize publicly in the forum where you committed the original mistakes. And here is why:

Mr. Loher, you acted in an official capacity as president of the school board addressing a matter of school district business in a public forum. At that time and place, you chastised a citizen who asked an honest question. You not only chastised that citizen publicly, you did so with information that was within your scope of knowledge, but was later proven incorrect. You (1) improperly chastised a citizen (2) publicly (3) with misinformation at your disposal (4) in an official capacity (5) on school district business.

Your obligation to apologize is not relieved by meeting in private with the victim. The victim cannot relieve or absolve you of your errors. You owe the apology to the public, where the errors were committed.

You see, you committed a public wrong as president in an official capacity on district business against a citizen you serve with misinformation in front of a public audience. To correct that wrong, you should admit that wrong in an official capacity against the citizen you serve admitting that you wrongly provided misinformation and wrongly chastised her in front the same public audience. This is the only way to correct that error.

Anything less is insufficient.

Now, your refusal and your delay have created layers of problems for the board (you serve) and the district (you are charged to lead). Your character and fitness to lead has now become a board issue and a district issue.

No one doubts that you have committed multiple mistakes, hence the need to meet with Ms. Barry. But now, your errors compounded by your denial and delay have placed additional burdens on the board, the staff, and the district. Is it your character that prevents your apology? Is it your lack of understanding that prevents your apology? Is it your pride that prevents your apology? And if so, are those flaws sufficient to impede your leadership of the board and district now and in the future.

Dear School Board,

I obtained 3 bids before choosing a painter to paint my house. I picked the lowest bid based upon comparable work. But this is not why I am writing.

I am writing because you did not get multiple bids to resurface the track at Moss Field. Why?

You are responsible to the taxpayers of our district for the spending of \$52 million dollars. Every single year. And carefully, I might add. I urge you to take this responsibility seriously. I question whether you have acted responsibly to the taxpayers of the district in spending taxpayer money. At the April 18 board meeting, this board was presented only one (1) bid for the resurfacing of the high school track. There was no discussion of the other bids because there were no other bids. Why?

Don't tell the taxpayer that the administration wasn't aware that resurfacing was needed. Don't tell the taxpayer that the resurfacing of a track was an emergency. Why could the resurfacing of a track be a surprise that appeared to cause a fire drill when the administration has known for nearly a decade that the track would need resurfacing? (The current track was laid in 2000 and tracks are guaranteed for ten years).

Your questions should have included: Why must we use a certified company? Is a non-certified resurfacing of a track also guaranteed for ten years? Perhaps it is acceptable to close the track for two weeks if it saves \$20,000 or so. Now all these questions are debatable, but what ISN'T debatable or excusable is that only ONE bid was presented to the board. When Webster Groves school district taxpayers have work done on their personal homes, it is customary, common knowledge, and common sense to solicit at minimum three bids for any work.

How can you possibly be spending taxpayer money wisely without a single comparison?

I urge you to advertise for bids for the resurfacing and get multiple comparable bids. And award the contract to the lowest bid for comparable work. Before spending considerable amounts of money again, the district should follow a process to ensure the maximum result.

I further urge you to demand three bids from the administration on all future projects.

Dear John and board members,

Filling the WGSD CFO/COO position is perhaps, in many ways, more critical to do well than even filling the position of the superintendent. I think it is certainly of equal importance.

I wasn't able to attend this evening's board meeting, but was told, "Dr. Moore, who has resigned the CFO/COO position, has highly recommended a replacement to serve in an interim

capacity, until a permanent replacement can be hired in the 2017-18 school year. Dr. Simpson will be meeting a person of interest at Bread Co. tomorrow morning, from a neighboring - competitive school district."

I hope this is not the plan. I realize the extremely tight time line you have to hire a top caliber COO/CFO. Hiring an interim is likely the only logical option at this late date. You must, however, advertise for top caliber, experienced interim candidates, must do a thorough review of their performance and not rush into having this process blunted because the departing superintendent and/or COO/CFO know someone or a few people who might be interested. This is a position of great magnitude. The interim person will manage a 63 million dollar budget and all WGSD operations. This is not a position "someone who knows someone" should be able to negotiate taking. I think you need to turn to professional organizations to help you fill it through proper processes.

Public accounting firms have CPAs who function as 'consultants" who fill in "gaps" like this one all the time. CPAs are competent in all aspects of finance, operations, logistics, production, marketing and all areas of business operations. An outstanding, independent, competent, neutral person should be sought, via proper advertising of the position and proper due diligence. I suspect the accounting society, DESE and/or the MSBA and likely other organizations might be able to produce for you capable CPA/school CFO applicants. Clear expectations and proper posting/advertising must be done and candidates should be properly and carefully vetted.

For this position to even be considered, even if only for a few months, much less a fiscal year, to be handed over to someone "handpicked" is astonishing. For the "meeting" with this mystery person to be taking place in a public restaurant in an informal setting without proper posting of the position, vetting, extensive research into performance of several candidates is really unbelievable.

Interim COO/CFO candidates should be of the highest caliber, CPAs with extensive public school experience, completely objective, with no association with Drs. Riss or Moore.

The interim role is one that lends itself to having the "temporary change agent" really examine operations and systems with a critical, neutral and objective eye, to facilitate best practice and to assure strides toward top operational efficiency. An interim, objective, well screened, professional, experienced interim COO/CPA would consider nothing "sacred' and all options on the table. After this period of months or a year, the board would be well positioned to properly search and place a permanent COO/CFO.

Please, do not minimize the gravity of the decision you have before you, to advertise for, search and fully research candidates before hiring an interim for the WGSD COO/CFO position. I suspect you have resources to help you do it rapidly, but thoroughly.
